
**Sub: Issue of endorsement to Pharmacists on student VISA**

Please be informed that this council can register and issue Registration certificate to the pharmacists who are eligible as per section 12 of the Pharmacy Act 1948 and can submit a declaration that he / she intends to or residing within the state of Karnataka, India, to practice pharmacy, after due verification of the relevant documents.

However, this council would issue a formal endorsement letter as per the format given below, instead of Registration certificate .to those pharmacists who have come to India on a student VISA and are unable to furnish above declaration due to limitations imposed on their VISA.

Since the council has to perform detailed verification of all relevant documents identical with the registration process, (excepting the Registration of the pharmacist) the fee Rs 500/- already fixed for the verification of certificate would apply to this verification also.

This will come into effect from 1<sup>st</sup> July 2013.
